The essential oil of Eucalyptu Smithii Oil as it is, is not impacted by the IFRA code for its use in perfuming compositions, however, the components listed above are impacted.

Essential Oils containing substantial amounts of Limonene** and Linalool** should only be used when the level of peroxide is kept to the lowest practical level by the addition on antioxidants in production.
